## **STATEMENT OF DR JOHN BEVAN-SMITH**

I refer to an article published on the Poisoned Kiwi Substack dated 3 August 2024 entitled "Honestly Sam and Mark Bailey? Heterodoxies and The Truth Behind 'A Farewell to Virology'". To borrow the famous words of Justice Peter Mahon, this article is "an orchestrated litany of lies" that is utterly preposterous in its claims and profoundly malicious in its intent.<sup>1</sup>

For the record, I am the sole author and copyright owner of the originating document I converted into the Statement of Claim, first mentioned at page 2 of the article above, which I gave to the Heterodoxies Society for the purpose of it commencing proceedings in the New Zealand High Court pursuant to the rules of the Society.

By way of a Resolution dated 1 August 2021, the members of the Society endorsed the Statement of Claim and appointed me to be the authorised Agent to represent the Society in legal proceedings. Those who supported this Resolution with their signature includes the author of the above Substack article. The redacted Resolution and the signatures are attached, together with the minutes of that meeting.

I filed the Statement of Claim in the Auckland High Court on 6 August 2021. On 8 August 2021, I received an email from the author of the above article stating that I had no authority to act on behalf of the Society despite his having signed the above Resolution seven days prior. In the interim, a late draft version of the Statement of claim was stolen from copies I had stored for safekeeping on the hard drives of the "Poisoned Kiwi" author and another Society member and which was given without my knowledge or permission to a media company to publish. On 16 August 2021, the latter member resigned from the Society, as did the "Poisoned Kiwi" the next day. On 27 August 2021 the draft Statement of Claim was published online by the media company claiming it had the Society's permission to do so. The media company was notified that it was in possession of stolen property and ordered to take down the document, an order the company ignored. As the court had not yet released the Statement of Claim back to the Society for service, this could have had serious legal repercussions for myself as the person who had filed the proceeding on behalf of the Society.

This destructive behaviour had a devastating effect on the Society and on those members organising support for the proceeding.
