we noted your comment on the Substack article "Narcissists Who Hate The Baileys"¹ and your request to contact you via this email address. Sam and I do not usually get involved in the comments sections of our various platforms and certainly prefer that people contact us via the [website](#) if there are concerns. Please respect that my email address is a private one and I request that you redact it if you wish to publish my statements.

It was concerning that individuals purporting to be "truth tellers" were aware of Craig Hutchinson's defamatory lies about us but failed to call out the fraud and certainly failed to notify us about it. Hence the meme in the video suggested they are attracted to lies as flies are attracted to dung. A brief investigation into some of the accounts who 'liked' the post revealed that they were not interested in the truth and instead were attempting to discredit us. Additionally, there is little doubt that Craig took it as your stamp of approval and it helped fan his delusions.

We have not felt any need to mention you previously but remain disappointed that you had *any* connection at all to such dishonest and disgraceful behaviour.
